## **QUALIFICATIONS**

## **CLEARANCE**

In meeting the criteria of Section 943.04351, Florida Statutes, <u>for the</u> "search of registration information regarding sexual predators and sexual offenders required before appointment," a background check is performed. Any applicant who has been convicted or had adjudication withheld in any misdemeanor within the past three (3) years or any felony offense, or if any criminal charges are pending of a crime that would disqualify him/her for employment in PCPS, shall not be accepted as a volunteer. Because PCPS values student safety, prior conduct may disqualify a volunteer applicant.
